# **Committee Reports**

Mr. Clifford asked if there were any committee reports.

**Legislative Affairs Committee** – Mr. Clifford asked if the committee needed to hold a meeting and Mr. O'Kane requested to wait until the fall.

**Finance Committee** – Mr. Hewitt reported on his meeting with Mr. Marshall regarding the final budget that was presented to administration. Mrs. Dore wanted to know if the reduction in the travel budget would impact their travel to Columbia to complete the required certification classes offered by the State Election Commission.

Mr. Hewitt noted, after Mr. Marshall reviewed the previous budget year expenditures, he felt content with the updated budget.

**Facilities Committee** – Mrs. Stewart stated the lease for the voter registration office expires in November; however, Mr. Marshall is working with Mr. Gary Kubic, County Administrator.

**Precinct Reapportionment Committee** – The Precinct Reapportionment Committee possibly would not start until August. The board discussed at length the proposed new makeup of the Beaufort County house and senate districts.

**Rules Committee** – Mr. Rowe passed out a draft of a potential new operating manual. The Rules Committee needs to meet before the August board meeting.

# **Executive Director's Report**

**Senate Bills:** 

404 (SC UOCAVA Act)

(Mrs. Marie Smalls, deputy director, presented the Executive Director's Report.)

City of Beaufort Special Election – The election is to be held on July 19, 2011. There is one seat to fill and about 6,900 voters. The election involves eleven precincts (six partial precincts and five whole precincts). Some of the precincts are temporarily combined for this election only. There are seven polling locations and thirty-one poll workers. EVRLs (Electronic voter registration list) will be used (one per precinct) and paper poll books would be at the precincts as backups. The poll manager training is scheduled for Thursday, July 14 from six o'clock p.m. to eight o'clock p.m. and Monday, July 18 from ten o'clock a.m. until noon. The absentee precincts in Beaufort and Bluffton were open for voting.

Mrs. Stewart and Mrs. Dore said they would be available if needed for the canvass hearing on July 21, 2011.

**2011-2012 Poll Workers Training Schedule** – Mrs. Smalls passed out a tentative training schedule for the 2011-2012 year. The board reviewed the schedule and held a discussion on dates, times and locations.
