CALL TO ORDER

Mr. Clifford called the canvass hearing to order at 10:00 am.

Mr. Clifford was sworn in by Mrs. Smalls, and then Mr. Clifford swore in the Board and Secretary then led the Pledge of Allegiance.

CANVASS HEARING

Mrs. Smalls broke seal number 4779 on the provisional ballot box. There were two provisional ballots inside.

Mrs. Smalls explained since only one ballot was counted, the voter was contacted and explained to the voter that by counting the one ballot, the voter's ballot secrecy would be revealed. Mrs. Smalls informed the Board Ms. Stafford was contacted and she requested her ballot to be counted in the official results.

The Canvass Hearing was paused to tabulate the results then reconvened at 10:40 a.m.

It was motioned by Mr. Severns to accept the results as certified and declare Mr. David Striebinger as the official winner for the School Board District 2 Special Election. The motion was seconded by Mr. Williams. It was voted upon and passed unanimously.

The Canvass Hearing was adjourned at 10:45 a.m. and the Board meeting was convened.

REVIEW OF MINUTES

Mr. Clifford asked if there were any additions or changes to the Board minutes from August 26, 2015, September 17, 2015, and October 22, 2015.

Mr. Severns motioned to accept the all the minutes. It was seconded by Mr. Williams. The motion was voted upon and passed unanimously.

UNFINISHED BUSINESS

Board Member Vacancy Procedure

The Board discussed the draft procedures, handed out by Mr. Rowe, for filing vacancies in the Board's membership, specifically section 3B and 3C, advertising the vacancy and notification of the vacancy. (Secretarial Note: A copy of the procedures is attached with the sections discussed at the meeting highlighted.)

Mr. Severns asked what the Board's actions in the procedures were. It was explained the applications and selecting of the Board member is conducted by the Legislative Delegation.

Mr. Massey inquired why the Legislative Delegation does not do the advertising. Mr. Severns answered it is the Board's requirement.

Mr. Hewitt asked for clarification of item 2A. Mr. Rowe stated to remove the first "Director".

Mr. Severns motioned to accept the Board member vacancy procedures as amended. It was seconded by Mr. Williams. The motion was voted upon and passed unanimously.

Mr. Clifford inquired if there was any New Business, hearing none; he turned the Board meeting over to Mrs. Smalls for the Director's Report.

Election Updates 2016

Filing for the 2016 Partisan seats opens Wednesday, March 16, 2016 and closes Noon, Wednesday, March 30, 2016. The announcements for the filing would be on Wednesday, March 2, 2016.

The offices up for election this year are:

- President/Vice-President
- US Senate
- US House (Districts 1 − 6)
- Solicitor (14th District)
- State Senate (Districts 43, 45, & 46)
- State House (Districts 118, 120, 121, 122, 123, & 124)

The Beaufort office would be open Saturday, February 13, 2016 from 9 am – 1 pm for in-person absentee voting.

The Public Testing of the voting equipment for the Republican Presidential Preference Primary would be conducted on Friday, February 5, 2016 at 10:00 am. The Democratic Presidential Preference Primary Public Testing would be conducted the following week, Friday, February 12, 2016 at 10:00 am.

Combined Precincts for Presidential Preference Primaries

Exit Polls/Vote Collection

Mrs. Smalls informed the Board there would be Exit Polls and Vote Collections conducted by Edison Research Surveys at the following precincts:

 - o Mossy Oaks 2 (Exit Poll)
 - o Burton 2C (Vote Collection)
 - Hilton Head 1B (Vote Collection)
 - Lady's Island 2B (Vote Collection)
 - Mossy Oaks 2 (Vote Collection)

Mrs. Smalls reminded the Board the Exit Polls and Vote Collections are allowable as long as it does not interfere with the election process.

Mr. Kemp explained what the Exit Polls consists of, where the surveyor is and how the vote totals would be collected. The Board discussed the Exit Polls and Vote Collections surveys. The Board will inform the clerks on the Exit Polls and Vote Collections.

The Board revisited the Poll Manager training and SC Code 7-13-72. (Secretarial Note: A copy is attached.)

SC Association of Registrars and Election Officials (SCARE) Conference

The South Carolina Association of Registrars and Election officials (SCARE) conference would be held on March 8, 2016 – March 12, 2016. Mrs. Smalls reported the deadline to register for the SCARE Conference has been extended to February 12, 2016 and currently nine staff members and seven Board members would be attending.
